



## How to subscribe

Start at [responsible-investor.com/membership/register/](https://responsible-investor.com/membership/register/)

### Step 1: Account Manager/Subscriber Manager details

- Provide full contact information for the person setting up the subscription (and who will be responsible for paying the invoice. If that person does not require a subscription themselves, they will have administrator access 'Account Manager').



### Step 2: subscription details

Select one of the following options:

- You are buying only one subscription on your own behalf or
- You are buying subscriptions for yourself and others or
- You are paying for the subscription on behalf of others (i.e. you will not be a subscriber yourself and will not have access to the site's content)



### Then:

- Select your RI Subscriber Package (**N.B. If you are interested in purchasing an unlimited (Platinum) subscription for your organisation, please contact the Team in the first instance; Email: [subs@responsible-investor.com](mailto:subs@responsible-investor.com) or Tel: +44 20 7709 2088/2093**)
- Include a "purchase order" number if required by your accounts department.

If you are purchasing either the Bronze, Silver, Gold or Platinum subscription package you will be able to add subscribers via the "Your Account" link (top right hand corner on the homepage) once your subscription account is active.



### Step 3: confirmation screen

- Check the details you have provided are correct.
- Use the "edit subscription details" button to go back and edit your choices or details.
- Select whether you want to pay by invoice or by credit card.
- Click the "Submit" button to confirm your subscription.



### Thank You For Your Subscription

The final screen sets out what happens next.

1. You will be sent an email from [subs@responsible-investor.com](mailto:subs@responsible-investor.com) requesting that you confirm your registration by clicking on the link provided.
2. Once you have clicked on the link in the email you will receive a confirmation of your subscription including an invoice (payable within 30 days), or an invoice paid receipt if you have paid by credit card.
3. Your subscription will be activated immediately.
